Childnet have recently developed educational resources to explore generative AI and how it can be misused, with a specific focus on using generative AI to edit a photo of somebody to make them appear nude or naked, sometimes called 'nudification'. – including [three lesson plans with teacher guidance](#) on the topics:

- What is generative AI and what can it be used for?
- Misuse of generative AI and the possible impacts
- Reporting nude images made using generative AI

There is also an [information leaflet for parents and carers](#) to support conversations at home.




The Safeguarding Board for Northern Ireland has published a review on addressing child criminal exploitation (CCE) in Northern Ireland.

Selected findings include: CCE in Northern Ireland uniquely intersects with contextual harms including deprivation, community violence, and paramilitary influence; there are significant gaps in professional systems, training, and strategic responses; confidence in data recording, National Referral Mechanism (NRM) usage, and CCE-specific training is low; and data storage, recording, reporting and information sharing emerged as areas of critical importance, along with staff supervision and support. [This report provides specific recommendations](#) to strengthen organisation readiness, improve training, and enhance identification and information sharing systems.



A SAFER LIFE ONLINE FOR WOMEN AND GIRLS.

Ofcom has published guidance calling on tech companies to step up to protect women and girls from online harms, including abuse, harassment, stalking, coercive control, and non-consensual sharing of intimate images. They are urging platforms to implement stronger safety measures, such as improved content moderation, default privacy settings, and abuse-prevention tools. This guidance was developed from victims insights, survivors, safety experts, women's advocacy groups and organisations working with men and boys. To read more click [here](#).



Nexus has been awarded funding to expand their services through the Domestic and Sexual Abuse Small Grant Scheme, supported by the Departments of Justice and Health. This funding will help with the delivery of trauma-informed counselling and support services such as crisis de-escalation therapy, and one-to-one legal advice clinics for victims and survivors to victims and survivors of domestic and sexual abuse across Northern Ireland.

The Northern Ireland Commissioner for Children and Young People (NICCY) has published a report on strengthening the case for equal protection from assault for children in Northern Ireland. The report draws on evidence and best practice across Europe to highlight the need for legislative reform on the physical punishment of children and young people. The research accessible [here](#) highlights the importance of embedding this change within a wider framework of family and parenting support, ensuring that parents are empowered and supported in non-violent approaches to raising children.
